2. PAYMENT TERMS

- Full payment is due at least 48 hours prior to the scheduled booking time unless otherwise approved by Landmark East School.
- Accepted methods of payment include e-transfer to payments@landmarkeast.org or cheque payable to Landmark East School.
- Bookings are not confirmed until payment has been received.

3. CANCELLATION POLICY

- Cancellations made by the Renter at least 48 hours prior to the scheduled booking time will receive a full refund or credit toward a future booking.
- Cancellations made by the Renter less than 48 hours prior to the scheduled booking time are non-refundable.
- Landmark East School reserves the right to cancel bookings due to school requirements, emergencies, weather conditions, or unforeseen circumstances. In such cases, a full refund or credit will be provided.
- Bookings cancelled due to weather-related school closures will receive a refund or credit.

4. USE OF FACILITY

- Rental includes use of the gymnasium only unless otherwise specified in writing.
- Set-up and take-down time must be included within the booked rental period.
- The Renter agrees to use the facility only for the purpose identified in this Agreement.
- Access is limited to approved areas of the facility.

5. SUPERVISION AND RESPONSIBILITY

- The Renter must provide adequate adult supervision at all times during the rental period.
- The Renter is responsible for the conduct and safety of all participants, spectators, guests and invitees.
- Unsupervised minors are not permitted in the facility.

6. RULES AND CONDUCT

- All participants are required to wear clean, non-marking footwear.
- Food and beverages are prohibited in the gymnasium, except for water, unless prior approval in writing has been granted.
- Smoking, vaping, alcohol, cannabis, and illegal substances are prohibited inside the gymnasium and anywhere on school property.
- All participants must respect school property, equipment, staff, and posted facility rules.
- Unsafe, disruptive, or inappropriate behaviour may result in immediate termination of this Agreement without refund.
- Landmark East School reserves the right to refuse or terminate facility use where the Renter fails to comply with this Agreement or where the use is deemed unsafe or inappropriate.

7. DAMAGE AND CLEANLINESS

- The Renter agrees to leave the facility in the same condition in which it was found.
- Any damage, safety concern, or maintenance issue must be reported immediately to gymnasium@landmarkeast.org.
- The Renter is financially responsible for any damage, loss, or excessive cleaning resulting from the actions of the Renter or any participant, spectator, guest, or invitee associated with the rental.

8. INSURANCE AND LIABILITY

- The Renter may be required to provide proof of liability insurance for certain rentals or events.
- The Renter assumes full responsibility for all activities conducted during the rental period.
- The Renter agrees to indemnify and hold harmless Landmark East School, its employees, volunteers, agents, and representatives, from any claims, liabilities, injuries, losses, damages, or expenses arising from the Renter’s use of the facility, except where caused by the negligence of Landmark East School.

9. ACCESS AND SECURITY

- Access to the facility will be provided at the scheduled rental time.
- The Renter must vacate the premises promptly at the conclusion of the booking period.
- Only authorized areas of the facility may be accessed.
- Parking is in designated areas as identified by Landmark East School.

10. EMERGENCIES

- In the event of a medical emergency, the Renter must call 911 immediately.
- First aid kits are located in the vestibule area.
- All accidents, injuries, incidents, or safety concerns must be reported as soon as possible to gymnasium@landmarkeast.org.
