## U.S. Friends of Landmark East School

**United States residents may make gifts to Landmark East School  
and receive a US tax receipt.**

Alumnae and friends in the United States have the opportunity to support Landmark East with the added benefit of charitable receipts for their donations.

FRISBE (**F**riends of **I**ndependent Schools and **B**etter **E**ducation) is a licensed U.S. non-profit organization that promotes and encourages educational institutions that emphasize scholarship, sportsmanship, moral character, individual responsibility and initiative. FRISBE directs donor gifts to various independent schools both within and outside the U.S.

The United States Treasury Department, Internal Revenue Service, includes the Friends of Independent Schools and Better Education in its "Cumulative List of Organizations" described in Section 170(c) of the Internal Revenue Code which are exempt from Federal Income taxes under section 501(c) (3) of the Internal Revenue Code. Contributions and gifts to the Friends of Independent Schools and Better Education are deductible for Federal Income Tax purposes to the full extent permitted by law. Federal Tax Number 91-1216755.

Landmark East School donors residing in the U.S. can make a donation to FRISBE and request that a grant be made to Landmark East School. In return, FRISBE will issue donors an IRS tax receipt and Landmark East will be notified by FRISBE that we have been selected to receive funding following FRISBE's next bi-annual meeting. Transfers from FRISBE to Landmark East will be made, in lump sums, at six-month intervals (March and September).
